AN ORDINANCE TO AMEND THE LEGAL DESCRIPTION OF ORDINANCE NUMBER 2001-451

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BAYOU LA BATRE, ALABAMA, as follows:

SECTION ONE: Section One of Ordinance Number 2001-451 is hereby repealed in its entirety and shall now read as follows:

Lot. 1, AHEPA, VIII Subdivision, according to the plat thereof recorded in Map Book 92, Page 63, in the Office of the Judge of Probate, Mobile County, Alabama, more particularly described as follows:

Commencing at the Northwest corner of Section 24, Township 7 South, Range 2 West, Mobile County, Alabama; thence run South 89 degrees 52' 55" East along the North line of said Section 24 a distance of 905.70 feet to the point of beginning of the property herein described, thence continue to run South 39 degrees 52' 55" East along said North line of Section 24 a distance of 405.00 feet to a point; thence run South 00 degrees 59' 57" East a distance of 350.00 feet to a point; thence run North 89 degrees 52' 55" West a distance of 354.99 feet to a point; thence run South 00 degrees 59' 57" East a distance of 397.65 feet to a point on the North right-of-way line of Padgett Switch Road, an 80 foot right-of-way; thence run South 75 degrees 14' 29" West along said North right-of-way line of Padgett Switch a chord distance of 51.48 feet to a point; thence run 00 degrees 59' 57" West a distance of 760.87 feet to the point of beginning, containing 3.718 acres, more or less.

SECTION TWO: That all other provisions and sections of Ordinance Number 2001-451 shall remain in full force and effect.

SECTION THREE: This Ordinance shall be come effective following its adoption and publication as required by law.
